

**SUMMARY ANNUAL REPORT FOR
THE GEORGE WASHINGTON UNIVERSITY SUPPLEMENTAL RETIREMENT PLAN**

This is a summary of the annual report for The George Washington University Supplemental Retirement Plan (Employer Identification Number 53-0196584, Plan Number 003) for the plan year January 1, 2020 through December 31, 2020. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by insurance contracts and a trust fund. Plan expenses were \$ 78,164,282. These expenses included \$23,228 in administrative expenses and \$78,141,054 in benefits paid to participants and beneficiaries, and \$0 in other expenses. A total of 16,103 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$1,456,481,801 as of December 31, 2020, compared to \$1,313,268,708 as of January 1, 2020. During the plan year the plan experienced an increase in its net assets of \$ 143,213,093. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$221,377,375, including employee contributions of \$38,269,457, earnings from investments of \$174,831,117, participant rollover contributions of \$ 7,895,994 and other income of \$380,807.
